Item 4. Resignation, Removal or Election of Registrant's Directors or Officers

Given that a majority of the Board of Directors of **Arthaland Corporation** still constitutes a quorum, and after the Nomination Committee vetted his qualifications, Mr. Fernan Victor P. Lukban was elected as Independent Director of the Corporation to act as such for the remainder of the term of Mr. Emmanuel A. Rapadas who resigned on 30 September 2019¹.

Mr. Lukban, Filipino, is a leading consultant in Family Business, Strategy, Entrepreneurship and Governance. He advises family boards of over a dozen of the most progressive and better governed family businesses in the country. His interests include helping build and grow family businesses, installing good governance practices and poverty alleviation. Over the recent years, he has put special focus on developing Base of the Pyramid Initiatives (BOPI) in various provinces in the Philippines. He spent much of his early professional years in the academe helping establish and grow the University of Asia & the Pacific where he still participates as a consultant, mentor and guest lecturer.

The current directorships of Mr. Lukban in listed companies are Century Pacific Food Inc., Central Azucarera de Tarlac and Shakey's Pizza Asia Ventures, Inc., where he is the Lead Independent Director of all three.

Mr. Lukban obtained a degree in Mechanical and Industrial Engineering from the De La Salle University. He received his MBA from Instituto de Estudios Superiores de la Empresa (IESE) and MSc in Industrial Economics from the University of Asia & the Pacific.
