Item 9. Other Events

At its recently concluded meeting, the Board of Directors of ArthaLand Corporation (the "Corporation") approved the issuance of fixed rate peso-denominated ASEAN green bonds in the aggregate principal amount of Six Billion Pesos (P6,000,000,000) ("Bonds") to be registered under shelf registration with the Securities and Exchange Commission ("SEC"), and to be issued in one or more tranches within a period of thee (3) years from the date of effectivity of the Registration Statement.

Further, the Board approved, confirmed and ratified the execution by the Corporation of definitive agreements with Help Holdings, Inc. (HHI) and Savya Land Development Corporation which outline their respective rights and obligations in the implementation of the Arca South Project as defined below. In an earlier disclosure¹, the Board approved, confirmed and ratified the proposed merger of Savya with Arcosouth Development, Inc. ("Arcosouth"), with Savya as the surviving entity. HHI is the majority shareholder of Arcosouth.

Savya and ArcoSouth have opted to undertake a merger for the purpose of consolidating the ownership of their properties in Arca South, FTI Compound, Barangay Western Bicutan, Taguig City, in one investment vehicle entity (Savya), and then jointly developing and undertaking the construction of two (2) office condominium buildings thereon, specifically, Tower 1 and Tower 2, which will be named "Savya Financial Center" (hereinafter referred to as the "Arca South Project")
