Item 9.Other Events

Amending previous approvals to the contrary, the Board of Directors of **ArthaLand Corporation** (ALCO) approved and ratified the further amendment to the Articles of Incorporation –

"SEVENTH – That the authorized capital stock of the Corporation is Philippine Pesos: Two Billion Nine Hundred Ninety Six Million Two Hundred Fifty Seven Thousand One Hundred Thirty Five and 82/100 (P2,996,257,135.82) divided into Philippine Pesos: Two Billion Nine Hundred Forty Six Million Two Hundred Fifty Seven Thousand One Hundred Thirty Five and 82/100 (P2,946,257,135.82) of common shares consisting of 16,368,095,199 common shares with a par value of Philippine Pesos: Eighteen Centavos (P0.18) per share and Philippine Pesos: Fifty Million (P50,000,000.00) of preferred shares consisting of 50,000,000 preferred shares with a par value of Philippine Peso: One (P1.00) per share.

"The preferred shares shall have such features as the Board of Directors may prescribe, provided that, in no case shall such preferred shares be voting or participating.

"The shares of stock of the corporation are not subject to preemptive rights of stockholders, and may be issued for the unissued portion of authorized capital stock in such quantities, at such times, and under such terms as the Board of Directors shall determine."

The foregoing matter will be presented for approval at the special stockholders' meeting on 07 September 2016, Wednesday, 8:30 A.M. at The Ascott Bonifacio Global City, 28th Street and 5th Avenue, Taguig City.

The Commission was requested to allow ALCO to make certain corrections to its Definitive Information Statement which was filed on 09 August 2016 and distributed to stockholders of record beginning 16 August 2016, which request was granted on 30 August 2016.

Thus, within five business days before the special stockholders' meeting, or not later than 31 August 2016, (i) the Commission's Order granting ALCO's request will be published in The Philippine Star, a newspaper of general circulation; (ii) an Amended Definitive Information Statement will be filed anew with the Commission; and (iii) a summary of the changes to the Definitive Information Statement will be distributed by mail to stockholders as of record date.
