SEC MSRD Order No Series of 2020
Registration of ASEAN Green Bonds (Shelf Registration)

ORDER OF REGISTRATION

Upon consideration of the Registration Statement and other papers and documents attached thereto which were filed on behalf of **ARTHALAND CORPORATION**, the Commission, resolved in its meeting on December 17, 2019 to render effective the same for the shelf registration of **Six Billion** (**PhP6,000,000,000.00**) **ASEAN Green Bonds**, in accordance with the requirements of Sections 8 and 12 of the Securities Regulation Code. The shares are broken down as follows:

- (a) Initial Tranche of Two Billion Pesos (PhP2,000,000,000.00), with an Oversubscription of One Billion Pesos (PhP1,000,000,000.00) Fixed Rate ASEAN Green Bonds due 2025, with an interest rate of 6.3517% per annum, to be listed and traded on the Philippine Dealing & Exchange Corp; and
- (b) Remaining Three Billion Pesos (PhP3,000,000,000.00) under Shelf Registration.

In this regard and after determining that the company has complied with the required submissions as directed in the Pre-Effective Letter issued on December 17, 2019, the subject Registration Statement is now rendered effective.

Let a **Certificate of Permit to Offer Securities for Sale** be issued in favor of subject company authorizing the sale and distribution of the aforementioned securities.

Let this **Order** be published at the expense of the Issuer in a newspaper of general circulation and uploaded in its website within two (2) business days from its issuance. The corporation is hereby directed to furnish the Commission with a copy of the affidavit of publication of this Order.
