Item 9. Other Events

During its meeting held on 04 May 2022, the Board of Directors of **ARTHALAND CORPORATION** (the "Corporation") approved the amendment of Article Seventh of the Corporation's Articles of Incorporation by reducing the authorized capital stock by ₱20,000,000.00, and endorsed the same for approval by the stockholders during the Annual Stockholders' Meeting on 24 June 2022, Friday, 9:00 A.M. The amendment is the result of the cancellation of 20,000,000 preferred shares given the redemption of Preferred Shares Series B in December 2021.

The amended Article Seventh of the Corporation's Articles of Incorporation will thus read, as follows:

"SEVENTH – That the authorized capital stock of the Corporation is Philippine Pesos: Two Billion Nine Hundred Seventy Six Million Two Hundred Fifty Seven Thousand One Hundred Thirty Five and 82/100 (P2,976,257,135.82) divided into Philippine Pesos: Two Billion Nine Hundred Forty Six Million Two Hundred Fifty Seven Thousand One Hundred Thirty Five and 82/100 (P2,946,257,135.82) of common shares consisting of 16,368,095,199 common shares with a par value of Philippine Pesos: Eighteen Centavos (P0.18) per share and Philippine Pesos: Thirty Million (P30,000,000.00) of preferred shares consisting of 30,000,000 preferred shares with a par value of Philippine Peso: One (P1.00) per share.

"The preferred shares shall have such features as the Board of Directors may prescribe, provided that, in no case shall such preferred shares be voting or participating.

"The shares of stock of the corporation are not subject to pre-emptive rights of stockholders and may be issued for the unissued portion of authorized capital stock in such quantities, at such times, and under such terms as the Board of Directors shall determine."

In view of the foregoing, and further to the disclosure dated 23 March 2022, the final agenda of the annual stockholders meeting shall be as follows:
