

#### Item 4. Resignation, Removal or Election of Registrant's Directors or Officers

At its recently concluded meeting, the Board of Directors of Arthaland Corporation (the "Corporation") approved, confirmed and ratified the appointment of Mr. Aristides Antonio C. Gonzales as the new Head of the Business and Project Development Department of the Corporation, with the rank of Vice President, effective 14 February 2022. Mr. Gonzales is a graduate of the De La Salle University with a Bachelor of Science degree in Civil Engineering, major in Structural Design, and he obtained his Masters in Business Administration from the Asian Institute of Management. He is a licensed Civil Engineer and a Real Estate Broker, with over 16 years of professional experience in the field of business and project development specific to the real estate industry. He spent the majority of his career in Alveo Land Corporation overseeing its expansion and development in key growth areas of the country such as Makati, Alabang, Nuvali, Cavite, Tagaytay and Cebu.

The Governance and Nomination Committee vetted the qualifications of Mr. Gonzales prior to the Board's approval of his appointment.
