(<u>Bhavana</u>), or 10,000,000 common shares of stock thereof, as well as the Corporation's shareholder advances therein with a principal balance amounting to P221,200,000.00, together with the accrued interest on such principal balance, for and in consideration of the total amount of P258,000,000.00.

The Board also approved on 15 December 2021 the sale, transfer and conveyance in favor of Narra, by way of secondary sale, all of the rights, title and interest of the Corporation in and to 40% of the common shares of stock of Bhavya Properties, Inc. (Bhavya), or 10,000,000 common shares of stock thereof, as well as the Corporation's shareholder advances therein with a principal balance amounting to P197,500,000.00, together with the accrued interest on such principal balance, for and in consideration of the total amount of P258,000,000.00.

The Board's approval was conditioned on the parties agreeing to the terms and conditions outlined in the definitive agreement provided by the Corporation.
