In relation to the offering by **Arthaland Corporation (the "Corporation")** of Fixed Rate ASEAN Green Bonds due 2025 amounting to P2.0 Billion, with an oversubscription option of up to P1.0 Billion, at an interest rate of 6.3517% per annum, the oversubscription option has been exercised in full.

Further, at its meeting held today, Independent Director Fernan Victor P. Lukban was appointed by the Board of Directors as a member and elected as the Chairman of the Audit Committee.

Finally, the Board approved the declaration of cash dividends to holders of Preferred Shares Series B (ALCPB) and Series C (ALCPC), as follows:
