

Following the provisions of the Prospectus and Offer Supplement both dated as of 21 November 2016 of **Arthaland Corporation** (the "<u>Company</u>") in relation to its issuance in 2016 of its Series B Preferred Shares, with trading symbol ALCPB, please be advised that the Company shall redeem on **06 December 2021** all of the outstanding 20,000,000 Series B Preferred Shares at a redemption price equal to the Offer Price thereof, plus accrued and unpaid cash dividends due them as of **06 December 2021**, after deduction of transfer costs customarily chargeable to stockholders, as applicable, to effect the redemption (the "<u>Redemption Price</u>"). The Redemption Price shall be paid to holders of the Series B Preferred Shares as of **16 November 2021**, which is the relevant record date (the "<u>Record Date</u>"), as previously disclosed.

A notice of redemption of the Series B Preferred Shares will be sent to the stockholders of record of such shares as of the Record Date.
