The Redemption Price shall be paid to holders of the Series B Preferred Shares as of **16 November 2021**, which is the relevant record date (the “*Record Date*”), as previously disclosed.

A notice of redemption of the Series B Preferred Shares will be sent to the stockholders of record of such shares as of the Record Date.
